The requirements related to the operation of a dispensary are included in NDCC Chapter 19-24.1 and North Dakota Administrative Code (NDAC) Chapter 33-44-01.

### Application Instructions: Dispensaries

An Operating Plan is required for all recreational marijuana applications. If you will operate under a formal Operating Plan, you may submit that information as a supplement, but this form is required. In addition to the Operation Plan, an approved security plan is required for all licenses. Use this form to meet that requirement.
